**RECOGNITION ORDER**

25 JUN 2018

1. WHEREAS in terms of Section 14(1)/15(1) of the NCTE Act, 1993, the institution had submitted application on 05.06.2016 to the Northern Regional Committee of NCTE for grant of recognition/permission for Teacher Education course.

2. AND WHEREAS on scrutiny/perusal, veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution in compliance to the decision of clause 7(13) of the NCTE Regulations, 2014, as amended from time to time the Northern Regional Committee having satisfied itself that the institution fulfils the requirements under the provisions of NCTE Act, Rules and the extant Regulations including the Norms and Standards for the proposed Teacher Education course, such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the course and has selected/appointed qualified teaching staff as per norms duly approved by the affiliating body, decided to grant recognition/ permission to the institution in its 285<sup>th</sup> meeting held from 05<sup>th</sup> to 08<sup>th</sup> June, 2018 for B.A.B Ed./B.Sc.B.Ed (integrated) course.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a)/15(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to the following institution for conducting Teacher Education programme with an annual intake mentioned against its name from the academic session 2019-2020 under clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014, as amended from time to time, subject to fulfilment of the conditions mentioned below:-

It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the Regional Committee along with new land documents within the stipulated time.

10. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by the MHRD.

11. The Institution shall fill the GIS Application within one month from the date of issue of this order.

12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules and Regulations, the Regional Committee shall withdraw recognition under provisions of Section 17(1) of the NCTE Act, 1993.

13. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order.
